## SHELTERBOX NORD ITALIA - ONLUS HUMANITARIAN ORGANISATION ARTICLES OF INCORPORATION

### ARTICLE 1 - Name, location and duration

The Charity **SHELTERBOX NORD ITALIA - ONLUS** based in Genoa, Italy, piazza Leonardo da Vinci 5/2. In any mark, logo or communication whatever, the words *Organizzazione non lucrativa di utilità sociale* or the acronym **ONLUS** will be always used.  
The Charity's duration is perpetual.

### ARTICLE 2 - Principles

The Charity works in close coordination with **ShelterBox**, a Charity based in Cornwall and registered under the laws of England and Wales.  
The Charity was founded at the initiative of Italian Rotarians: in both internal and external relations, its action and methods are inspired by the ideals of **Rotary International**.  
The legal structure of the Charity will comply with the legal principles of the **European Union**, as established by the Court of Justice of the Union. In case of uncertainty, the present Charter shall be interpreted in that light; further reference is made to the Italian law, if needed.  
Mandatory provisions of Italian law will prevail in any case, and the rules set for the **ONLUS** by Italian law, that prevail on any other source: any provision contrary to the **ONLUS** provisions will have no effect.

### ARTICLE 3 - Goals and purposes

The Charity pursues exclusively charitable purposes by carrying out activities in the domain of the social and health services, and especially the promotion of humanitarian aid directed to members of foreign communities. The Charity is not allowed to engage in other activities, except those directly connected to the former.  
The Charity's goal is to cooperate in the care of people affected by disasters, in particular by providing equipment and materials for shelter and survival, focusing on quick aid delivery and safeguard of human dignity.

### ARTICLE 4 - Patrimony of the Charity

The Patrimony of the Charity is composed by movable property, property or money, given at the time of incorporation or at a later moment, and any grants, donations and bequests from members or third parties.

### ARTICLE 5 - Fiscal year and budget

The fiscal year is from January 1 to December 31 of each year.  
For each year, budget and final balance must be drafted by the Board of Directors, and submitted to the General Meeting for adoption.  
The final balance will analytically inform about the gifts, contributions and bequests received and the expenses sustained.  
The Charity will spend profits or operating surpluses in its statutory activities. It is forbidden to distribute, even indirectly, profits and surplus funds, reserves or capital during the life of the organization, unless the use or distribution is required by law or is made to other **ONLUS** that by law, statute or regulation is part of the same structure.

### ARTICLE 6 - Members

Members may be:

- individuals, whether or not EU citizens;
- Rotary Clubs and other entities other than individuals;

which agree with the purposes of the Charity and accept these Articles of Incorporation. Applications for membership are accepted by the Board of Directors, that is not required to justify its decisions, that cannot be tacit.

The Members all have equal rights and duties.

The Board of Directors may also award the title of:

- Contributor, to those who pay an yearly sum especially fixed by the Board of Directors. The status of Contributor and Member are mutually independent;
- Honorary Member, to those who gave outstanding contributions to the goals of the Charity,

whether or not he/she has been active within the Charity itself. He/she has the privileges of the Member, but is not required to pay a fee.  
Membership cannot be temporary.

### ARTICLE 7 - Rights and obligations of Members

Members actively contribute to the achievement of the goals of the Charity and pay the yearly fee fixed by the Board of Directors. The members personally contribute to the activities of the Charity, under no duress and without any wage.  
Members share the guidance of the Charity through the General Meeting: the voting rights belong equally to all members whatever the subject, including the approval and amendment of the Articles of Incorporation and other Regulations and the appointment of the Charity's Officials.  
Charity's Officials are unpaid; Members will be reimbursed for actual expenses incurred in according to uniform rules, that apply to all Members, previously determined by the Board of Directors.  
In no case sums paid to the Charity can be claimed back.  
Membership is not transferable.  
Members specify the email address that will be used for communications from the Charity: if they wish, Members may require the use of certified electronic mail, stating the address of a mailbox of that kind.

### ARTICLE 8 - Loss of membership

Resignation of the Member will take effect thirty days after reception from the Headquarters; within such term it can be withdrawn.  
Membership can also be cancelled when a member has been guilty of dishonourable behaviour or actions that put at jeopardy the attainment of Charity's goals: this decision is taken by the Board of Directors in a secret ballot; the absolute majority of the members of the Board of Directors is required.  
Members failing to pay the dues are notified via email by the Treasurer: If the dues are not paid on or before thirty days of the date of notification, membership is terminated by the Board of Directors.

### ARTICLE 9 - Officials

The permanent Officers of the Charity are the following:

- General Meeting;
- Board of Directors;
- President;
- General Delegate;
- Administrative Delegate;
- Treasurer;
- Board of Auditors.

### ARTICLE 10 - General Meeting

Members are invited to attend the meeting by the Board of Directors at least once a year in order to approve budget and final balance. A notice must be sent via email, at least ten days before the date fixed for the meeting, to each member; it will contain agenda, place, date and time of the meeting.  
The General Meeting may be convened at the registered office or elsewhere in Italy.  
The Directors may call a meeting whenever it considers it appropriate, is required to do so upon request, in writing or by email, from at least a fifth of the Members.  
The General Meeting:

- approves the final balance and the budget;
- approves the guidelines and general directives of the Charity;
- appoints the members of the Directors and the Auditors, as specified in its articles;
- amends these Articles of Incorporation;
- adopts the resolution of dissolution of the Charity;
- decides any other issue submitted by the Board of Directors.

Members may all take part to the General Meeting and vote; vote can be expressed via a written proxy to another Member, but no Member can receive more than five proxies.

The meeting is chaired by the President, and in his/her absence by the General Delegate; if the latter is absent too, the oldest Member will chair the General Meeting.  
The Chairman shall appoint a Secretary of the Meeting and, if deemed appropriate, two Tellers.  
The right of the Member to attend the General Meeting and the validity of proxies is checked by the Chairman.

Minutes of the meetings is drawn up and signed by the Chairman and the Secretary of the Meeting and, if appointed, by the Tellers.  
The General Meeting is valid with the presence of at least one quarter of the Members, the decisions are taken by majority of those present. The amendment to these Articles of Incorporation and the dissolution of the Charity may, however, be passed only with the vote of the absolute majority of members.

## ARTICLE 11 - Board of Directors

The Board of Directors is in charge of the administration of the Charity, and performs any function that these Articles of Incorporation does not expressly assigns to other officials.

The Board of Directors is composed of five to nine Directors, all Members.

Directors are appointed for three years, and may be re-elected.

The General Meeting called for the election of the Board of Directors shall decide on the number of Directors of the Board of Directors.

Election will then take place, at secret ballot; each Member is allowed to vote more than one person, till to a maximum equal to the number of Directors that will sit in the Board. Those who will have obtained the higher number of votes will be elected. Where requested by at least a quarter of the members present, the election will take place with *Victor d'Hondt* party-list method, using all natural numbers as divisors.

Directors lose their position if they are absent without justification for three consecutive sessions. In this case the first unelected is appointed, and the same applies if the Director is no longer a Member. If no unelected Members are available, the Board of Directors will co-opt a new member. In any case, the new Director will step out of office at the same time of the other Directors.

The Board of Directors elects among Directors the following Officers: President, Director General, Administrative Delegate and Treasurer; they step out of their office if they are no longer Directors.

Board of Directors sessions are called upon via email by the President; he is compelled to call for a session on request of one third of the Directors, with provision of the agenda indicating the topics for discussion at least three days before the date fixed.

The Board of Directors sits if at least half of the Directors attend: resolutions are adopted with the vote of the absolute majority of those present. In case of a tie the President is awarded a casting vote.

At the end of each meeting will be drawn up a report, which will be signed by the President and the Administrative Delegate.

## ARTICLE 12 - President

The President implements the resolutions of the Board of Directors, and represents the Charity before third parties and in Court. He/she monitors the general performance of the Charity and perform such other functions awarded by these Articles of Incorporation.

The President must cooperate with the General Delegate on every issue that affects the tasks of the latter.

In case of conflict, the matter shall be brought without delay to the Board of Directors, whose decision are binding for all the officers of the Charity, excluding Auditors and Umpires.

## ARTICLE 13 - General Delegate

The General Delegate is in charge of the relationship with the ShelterBox headquarters and sister organizations in the world; he/she keeps at any time the President informed of any event. He/she acts *en lieu* of the President in case of absence or other impediment.

The last paragraph of the preceding article applies.

## ARTICLE 14 - Administrative Delegate

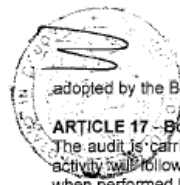
The Administrative Delegate assists the President; he/she keeps records, reports and any other documentation about internal life and external relations of the Charity, in both financial or non-financial matters. Countersign the payment orders signed by the Treasurer.

## ARTICLE 15 - Treasurer

The Treasurer has responsibility for the Charity's funds, manages banking affairs, takes care of debt collecting and performs, after countersignature of the Administrative Delegate, payments due and those decided by the Board of Directors.

## ARTICLE 16 - General provisions about Charity's Officers

President, General Delegate, Administrative Delegate and Treasurer are not allowed to take resolutions on their own, and cannot order expenses or undertake financial obligations of any kind. The Board of Directors may delegate to any of the Directors the implementation of decisions



adopted by the Board of Directors itself.

## ARTICLE 17 - Board of Auditors

The audit is carried out by three auditors, elected in the same way the Board of Directors. Their activity will follow the rules in force, at any given time, for the audit of Italian *Società per azioni*, when performed by a *Collegio Sindacale*.

## ARTICLE 18 - Umpires

Any dispute, however, may arise between:

- Members and the Charity and/or its Officers;
- Officers of the Charity, and/or against the Charity itself;

and is not to be imperatively heard by the Judicial according to Italian Laws, will be decided by a panel of Umpires that will judge *ex bono et aequo*, without any procedural formality. The panel will consist of three Umpires, each of them Rotarian Past Governors, appointed as follows:

- the first is appointed by the Governor of the Rotary District that includes the Club of which the President of the Charity is member. If the President is not a Rotarian, the appointment will be made by the Governor of the Rotary District that includes the place of the registered domicile (*residenza*, according to Italian Law) of the President of the Charity;
- the second in the same way, but taking into account the General Delegate, instead of the President;
- the third will be jointly appointed by the first two Umpires. If they are not able to reach an agreement, the appointment will be made by the President of the Notarial Council of the Charity's legal seat.

## ARTICLE 19 - Assignment of assets

In the event of dissolution for any reason of the Charity, its assets, unless otherwise required by law, will be assigned to another ONLUS or for other public purposes; the inspection body referred to in Article 3, paragraph 190 of the Italian Law of 23 December 1996, n.662 must be summoned for advice.

Mr. DIKSA declares he does not speak Italian; he asks to employ English, that the other parties and myself know: this deed will therefore be in English. I am certain of the personal identity of the parties, all Citizens of the Union, who agree as follows.

1. The parties incorporate the Charity **SHELTERBOX NORD ITALIA – ONLUS**, whose seat is in Piazza Leonardo da Vinci 5/2 Genoa, Italy. The parties are all Regular Members of the Charity.
2. The Charity is incorporated under the Articles of Incorporation hereto attached, under "C" (in Italian) and "D" (English translation I prepared myself).
3. Giorgio Vannucci, is appointed President; Giancarlo Andrioli, General Delegate; Massimo De Vincentiis, Administrative Delegate; Luca Trabattoni, Treasurer.
4. The Board of Directors is composed by the said Officers and by: John Diksa, Giovanni Arimondo, Giorgio Gandus, Maria Luisa Vacchino.
5. The Board of Auditors is composed by:
  - CASTELLO Antonio, born in Genoa, September 28<sup>th</sup> 1959, living in Genoa, via Federico Delpino 37/4, Italian *codice fiscale*: CSTNTN59P28D969S – Chartered Italian Auditor number 12176, since April 21<sup>st</sup> 1995; PRESIDENT;
  - CASTELLO Giovanni, born in Genoa, June 24<sup>th</sup> 1966, living in Genoa, via Biasioli, 383, Italian *codice fiscale*: CSTGNN66H24D969U – Chartered Italian Auditor number 12180, since April 21<sup>st</sup> 1995;
  - FOSSATI Nicola, born in Genoa, December 6<sup>th</sup> 1964, living in Genoa, via Salgarì 209/24, Italian *codice fiscale*: FSS NCL 64T06 D969P – Chartered Italian Auditor since June 13<sup>th</sup> 1995.

6. The term of all the officers hereby appointed will expire when the final balance 2013 will be approved.
7. Until February 15<sup>th</sup> 2011, the Board of Directors may award the title of *Founder* to any new Member. Such designation is purely honorific, and does not grant any priority, privilege or special status.
8. Until June 30<sup>th</sup>, 2012, the Board of Directors is allowed to drop the word *NORD* from the name of the Charity. This provision is extraordinary; the Board does not have the power to modify any other section of the Articles of Incorporation.
9. Until further resolution of the Board of Directors, the yearly fee is:
  - for individuals:
    - 50 (fifty) euro, if regular Members;
    - the amount required by ShelterBox (UK) for one box, if Contributors;
  - for other Members: the amount required by ShelterBox (UK) for one box.
6. Each of the parties is allowed to request an Italian *codice fiscale* for Mr. Diksa, if needed.

I have myself written the Italian and English text of this deed on three sheets of A4 paper; it is partly handwritten and partly printed with electronic devices; the printout is arranged in order to have the two texts facing each other. Each text takes up one page and a part of the second. The parties, who meet the legal requirements, renounce the formal reading of the attachments, approve the deed I have read in both texts, and sign both with myself at Three-Fifty PM.

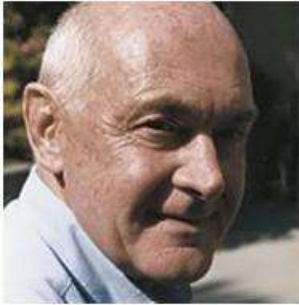

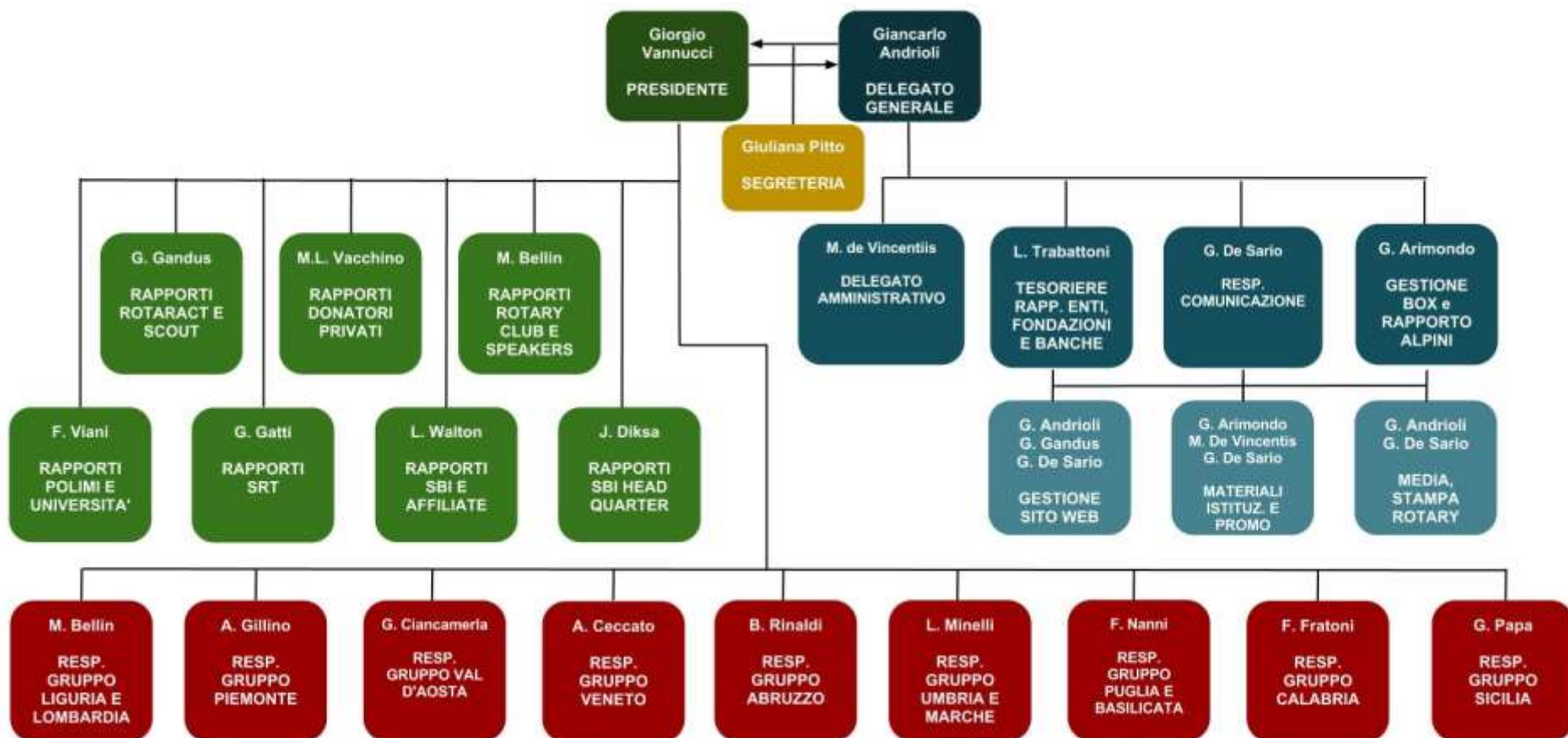
